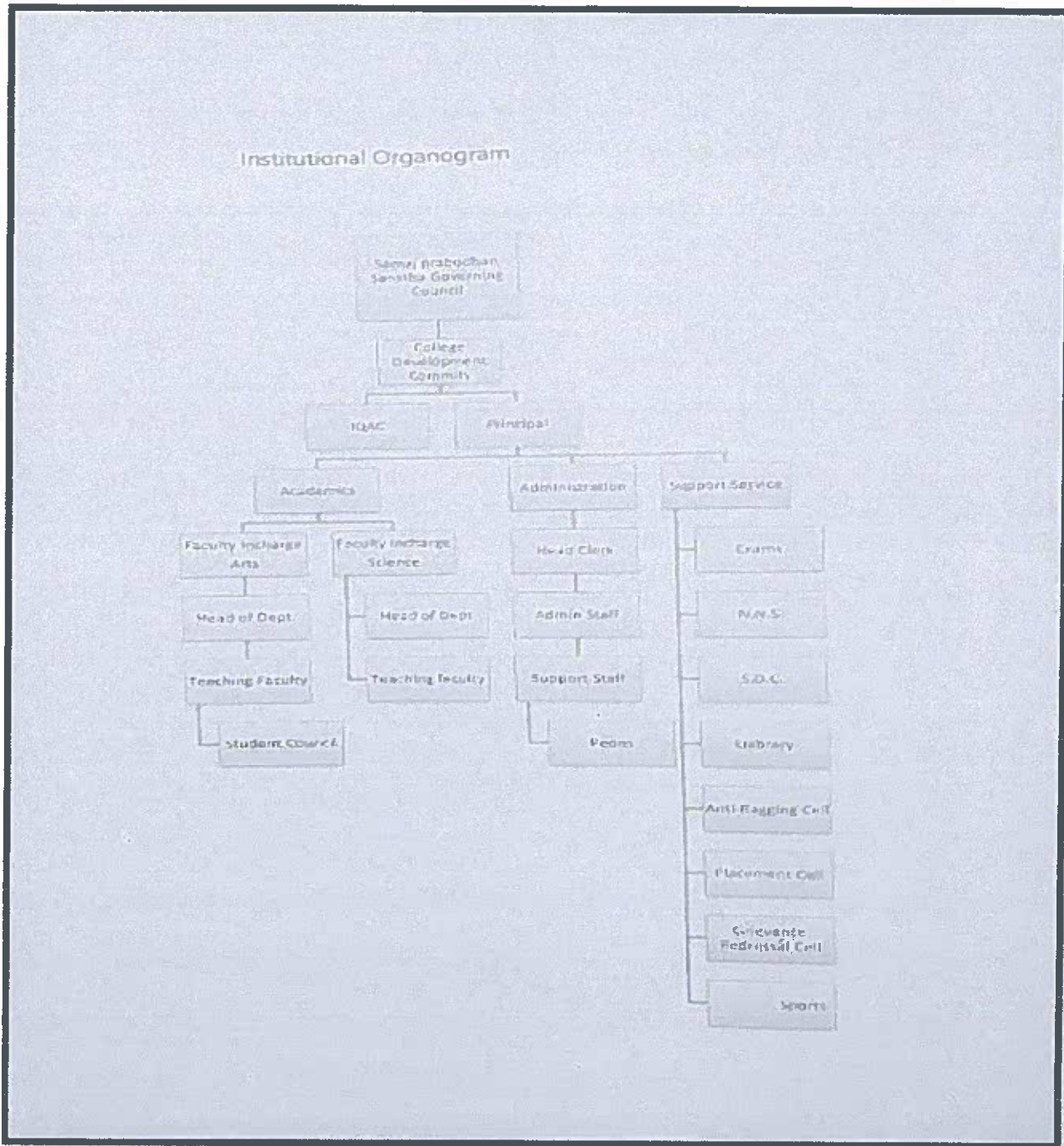

विद्यार्थी मित्राहे...

सामाजिक व राजकीय क्षेत्रात काम करत असताना कर्जतचे माजी सरपंच व प्रथम नगराध्यक्ष मा. नागदेव (देवा) राजत व तत्कालीन सचिव कॅ. आनंद करन्याणकर (टेलर) तसेच विद्यमान सचिव वैभवशेठ छाजेंड यांनी प्राचीण भागातील वाढती शैक्षणिक गरज विचारात घेऊन समाज प्रबोधन संस्थेची स्थापना सन १९९८ साली केली.

समाज प्रबोधन संस्था, कर्जत, ता. कर्जत, जि. अ. नगर या संस्थेने प्राचीण भागापयील शैक्षणिक सुविधा उपलब्ध करण्याच्या दृष्टीने आणि विशेषतः हुशार, होतकरू, व सामान्य स्तरातील मुलां-मुलींचे शिक्षणाची सोय व्हावी या हेतुने सन - १९९९ साली कर्जत येथे समर्थ माध्यमिक विद्यालय सुरू केले. तसेच सन २००३ साली संस्थेने उच्च माध्यमिक विद्यालय (कला व विज्ञान) सुरू केले. सन २०१४-१५ साली भारतीय पब्लिक स्कूल (इ. १ ली ते ५ वी सेमी) व सन २०१६ साली ग्लोबल इंग्लिश मेडियम स्कूल (सी. बी. एस. सी.) ची स्थापना केली. तसेच सन २०१३-१४ या शैक्षणिक वर्षात रोकडेश्वर माध्यमिक विद्यालयाची नांदगांव येथे स्थापना केली.

संस्थेने रक्तदान शिबीर, स्वच्छता मोहीम, वृक्ष लागवड, वेटी वधाव, जनजागृती इ. उपक्रम राबविलेले आहेत. संस्थेच्या अध्याक्षांच्या वाढदिवसानिमित्त शासकीय व खाजगी वसतिगृहातील गोर-गरीब विद्यार्थ्यांना शालेय साहित्याचे वाटप दरवर्षी करण्यात येते.

समाज प्रबोधन संस्थेने समर्थ विद्यालयातील गरीब कुटुंबातील होतकरू व हुशार मुलांच्या सर्व प्रकारचा शैक्षणिक खर्च संस्था करत आहे. विद्यालयात गुणवंत

खेळाडू निर्माण झालेले आहेत. जिल्हा विभाग, विभागीय विभाग, राज्यस्तर, राष्ट्रीय स्तरावर विविध खेळाडूंची निवड झालेली आहे. इ. १० वी व १२ वी परीक्षांचे निकाल वैयक्तिक निकाल ९०% च्या पुढे आहेत. संस्थेत शिक्षण घेतलेले विद्यार्थी मेडिकल, इंजिनियरिंग, बी. एस्सी. अंग्रेजी, डी. एड. या शाखांमध्ये उच्च शिक्षण घेऊन विविध क्षेत्रात काम करत आहेत.

उच्च शिक्षण देणे एवढेच महाविद्यालयाचे उद्दिष्ट नसून परिसरातील सामाजिक, शैक्षणिक आणि सांस्कृतिक लोकजीवन समृद्ध होण्यासाठी विद्यार्थ्यांच्या सर्वांगीण विकासासाठी घालना देणारी परिस्थिती निर्माण करणे, त्यांच्या जीवनाला निश्चित अर्थ प्राप्त करून देणे, तसेच महाविद्यालयातील विद्यार्थी विद्यार्थीनींवर सुसंस्कार करून जीवन मुल्यांचे महत्त्व पटवून देऊन विद्यार्थ्यांना शिक्षण देण्याचा मानस ठेवून महाविद्यालयाची स्थापना संस्थेने केली आहे.

महाविद्यालयात कला, विज्ञान या दोन्ही शाखेच्या पदवीपर्यंतच्या शिक्षणाची सोय संस्थेने केली आहे.

* शैक्षणिक सुविधा *

१) ग्रंथालय :-

ग्रंथ हेच गुरू या प्रमाणे महाविद्यालयात ग्रंथालय विभाग कार्यरत आहे. शैक्षणिक अभ्यासक्रमशिल्लय इतर संदर्भग्रंथ, नियतकालिके, स्पर्धापरीक्षा मार्गदर्शन पुस्तके, कथा कादंबरी, काव्य चरित्र इत्यादी. तसेच दै. वर्तमान पत्रासहित विविध ग्रंथ संपदा उपलब्ध आहे. महाविद्यालयामार्फत पुस्तक पेढीची सोय उपलब्ध आहे. तसेच विद्यार्थी विद्यार्थिनींसाठी वाचन कक्षाची सोय.

२) व्याख्यान व चर्चासत्रे :-

विद्यार्थ्यांच्या सर्वांगीण विकासासाठी विविध विषयात नामवंत व तज्ञ व्यक्तींची व्याख्यान महाविद्यालयात आयोजित केली जातात. तसेच विद्यार्थ्यांच्या बौद्धिक विकास व्हावा व त्यांच्यात सामाजिक बांधिलकी निर्माण व्हावी या दृष्टीने विविध विषयांवरील परिसंवाद व चर्चासत्रे तज्ञांच्या मार्गदर्शनाखाली महाविद्यालयात आयोजित केली जातात.

३) राष्ट्रीय सेवा योजना (N.S.S.):--

महाविद्यालयात विद्यार्थ्यांमध्ये सामाजिक जाणीव निर्माण करून त्यांच्या व्यक्तिमत्त्वाचा विकास व्हावा व त्याच बरोबर त्यांना समाजसेवेची संधी मिळावी म्हणून राष्ट्रीय सेवा योजनेचे (N.S.S.) पुणे विद्यापीठ व महाविद्यालय यांचे संयुक्त विद्यमाने विद्यार्थी / विद्यार्थिनींचे पथक महाविद्यालयात कार्यरत आहे.

४) क्रीडा विभाग :-

महाविद्यालयात मुला-मुलींना शारीरिक शिक्षण देऊन बौद्धिक विकासाबरोबर शारीरिक क्षमताही वाढावी म्हणून महाविद्यालयातील विविध खेळांची व विविध खेळाच्या मैदानाची सोय आहे. विद्यापीठामार्फत आयोजित केल्या जाणाऱ्या विविध स्पर्धामधून भाग घेऊन आपले क्रीडा नैपुण्य दाखविण्याची संधी उपलब्ध करून दिली जाते. प्रत्येक विद्यार्थ्यांना आपल्या आवडीनुसार खेळाची निवड करता येईल.

५) कला मंडळ :-

मनोरंजनाद्वारे शिक्षण यासाठी संगीत, नाट्य, नृत्य, गायन, पोवाडे, कथाकथन इ. कार्यक्रम कलामंडळामार्फत महाविद्यालयात राबवले जातात. वार्षिक नोंदरिचचे आयोजन केले जाते. तसेच महाविद्यालयात थोर व्यक्तींच्या जयंती, पुण्यतिथींचे आयोजन केले जाते.

६) इमारत :-

संस्थेने महाविद्यालयासाठी स्वतंत्र सुसज्ज इमारत बांधली असून, त्यामध्ये सुसज्ज ग्रंथालय, संगणक विभाग, प्रयोगशाळा, वर्ग व्यवस्था कार्यालय इ. स्वतंत्रपणे पूर्तता केली आहे.

७) अभ्यासिका :-

विद्यार्थ्यांना नियमित अभ्यास करण्याच्या दृष्टीने ग्रंथालयास सुसज्ज कार्यालय सह अभ्यासिकेचे नियोजन महाविद्यालयाने केले आहे.



८) स्पर्धा परीक्षा मार्गदर्शन केंद्र :-

महाविद्यालयातील विद्यार्थ्यांनी नियमित अभ्यासाबरोबर स्पर्धा परीक्षांत उतरावे यादृष्टीने स्पर्धा परीक्षा मोफत मार्गदर्शन केंद्र सुरू करण्याचा महाविद्यालयाचा मानस आहे. त्याचबरोबर विद्यार्थ्यांना नोकरीची शाश्वती नसल्याने स्वयंरोजगार व स्वयंवसाय भिळावा म्हणून व्यवसाय मार्गदर्शन केंद्र महाविद्यालयात सुरू करत आहेत.

९) विद्यार्थी सुव्यवस्था विभा योजना :-

सावित्रीबाई फुले पुणे विद्यापीठाच्या वतीने राबविण्यात येणाऱ्या विद्यार्थी सुरक्षा विभा योजने अंतर्गत महाविद्यालयीन विद्यार्थ्यांचे अपघाती निघन झाल्यास किंवा अपघाताने जखमी झाल्यास नियमानुसार फायदे मिळवून दिले जातात.

१०) कमळा व शिक्रा योजना (Eam & Learn) :-

केवळ आर्थिक अडचणीमुळे महाविद्यालयीन शिक्षणापासून वंचित राहणाऱ्या होतकरू विद्यार्थ्यांस महाविद्यालयात भरपूर सवलती उपलब्ध आहेत. केवळ आर्थिक परिस्थितीमुळे उच्च शिक्षणापासून वंचित राहू नये यासाठी कमळा आणि शिक्रा योजना आहे.

श्रम करून शिक्षण घेऊन इच्छिणाऱ्या विद्यार्थ्यांना या योजनेद्वारे कामाची संधी उपलब्ध करून दिली जाते. श्रमाच्या मोबदल्यात व महाविद्यालयाच्या आर्थिक साहाय्याने विद्यार्थ्यांचे शिक्षण सुकर होते.

११) विशेष मार्गदर्शन योजना :-

विद्यार्थ्यांसाठी विशेष मार्गदर्शनपर योजना महाविद्यालयात कार्यरत आहे. तसेच झंजजी संभाषण कौशल्य शिकण्याचे नियमित तासिका घेतल्या जातात.

१२) विवेकवाहिनी :-

विद्यार्थ्यांना कृतिशील वैज्ञानिक जाणीव व विवेकी मूल्य विचार देणेसाठी विवेक वाहिनी हा उपक्रम महाविद्यालयात घालू आहे.

१३) समर्थ भारत अभियान :-

भारताचे महामहिम माजी राष्ट्रपती डॉ. ए.पी.जे. अब्दुल कलाम यांनी जे महासत्ताक भारताचे स्वप्न दाखविले आहे. त्याच्या परिपूर्णतेसाठी पुणे विद्यापीठाचे तत्कालिन कुलगुरू डॉ. नरेंद्र जाधव यांनी समर्थ भारत अभियान सुरू केले.
